- 5. A detailed summary for 4/1/22 4/1/23 of the applicant's accomplishments, types of tasks, events worked and project hours must be submitted; include all pertinent information. (photos from said events may be included)
- 6. A brief summary of the nominee's personal history in the American Legion Family. Include from whom he received his eligibility into the SAL from-- I.e.: (Father, Mother, Step-Father, Step-Mother, Grandfather or Grandmother) who served in the United States Armed Forces and when they served.
- *** Applications will not be opened until the night of judging. Therefore if any listed items
 from above are missing from the application packet unless listed as not required, the
 nominee will not be judged.
