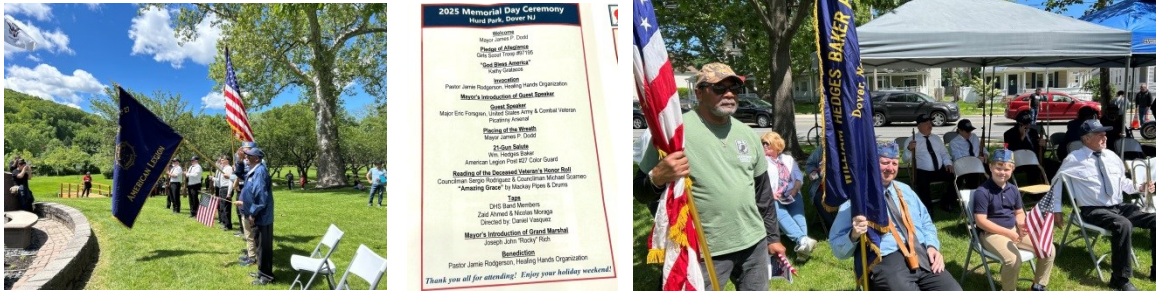
Memorial Day Events Around the State

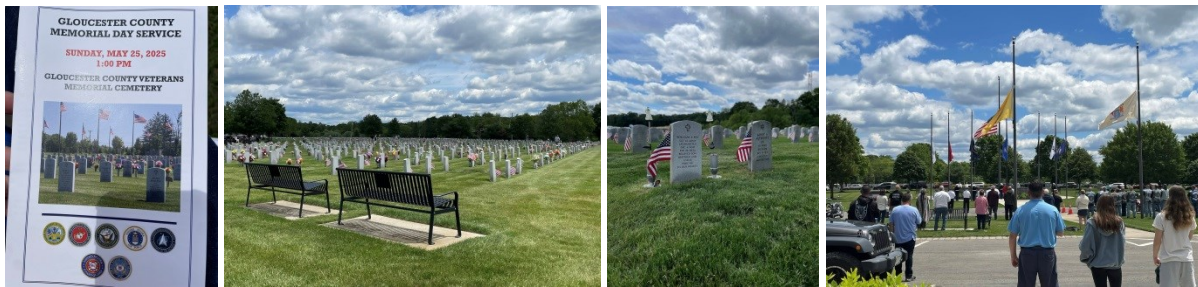

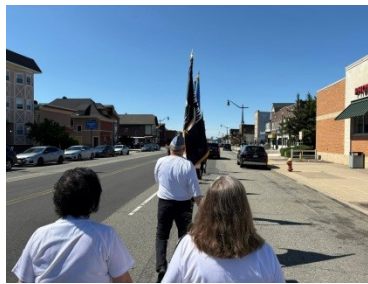

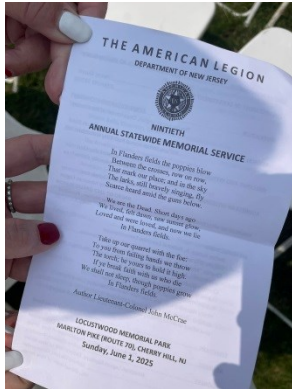

(5) Ownership, alteration, and disposition.

(i) All Government-furnished headstones, markers, and medallions remain the property of the United States Government in perpetuity and should not be defaced or altered in any way. Knowingly converting Government property to private use (such as using whole or partial headstones or markers in structures or landscaping or offering such items for sale) is a violation of Federal law under 18 U.S.C. 641.

(ii) Under 38 CFR 1.218(b)(5), the destruction, mutilation, defacement, injury, or removal of any monument, gravestone, or other structure within the limits of any national cemetery is prohibited, with an associated fine of \$500. Under 18 U.S.C. 1361, willful depredation of any property of the United States (i.e., a headstone or marker in a non-national cemetery) shall be punishable by a fine or imprisonment under title 18 of the United States Code.

(iii) When a Government-furnished burial headstone, marker, or medallion is removed from any cemetery, it should be properly disposed. Unless a headstone or marker that has been removed from a cemetery would be maintained by NCA for historic purposes, or in cases of disinterment would be relocated to a different gravesite, such headstones or markers made of stone must be physically broken into small enough pieces to ensure no portion of the inscription is legible and to ensure no part is available for any private, personal, or commercial use, and those made of bronze must be returned to VA for recycling.

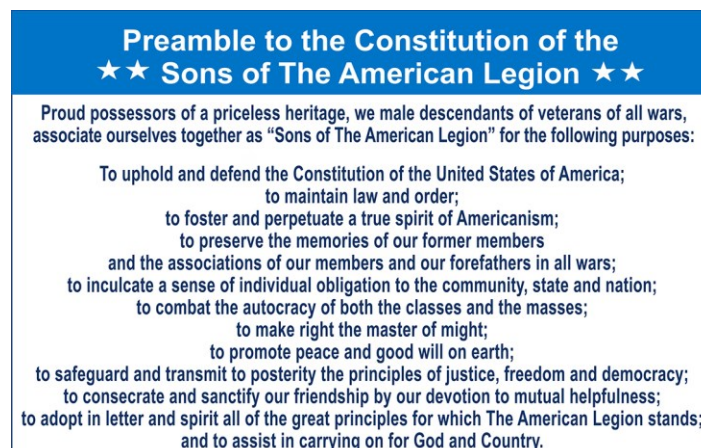

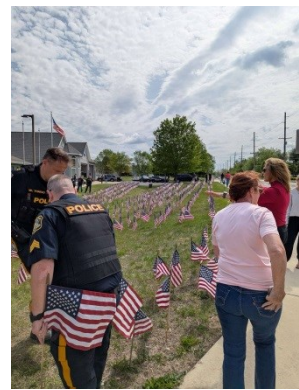
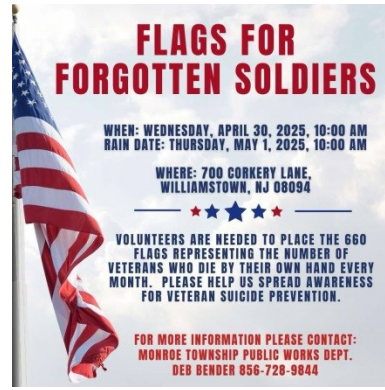

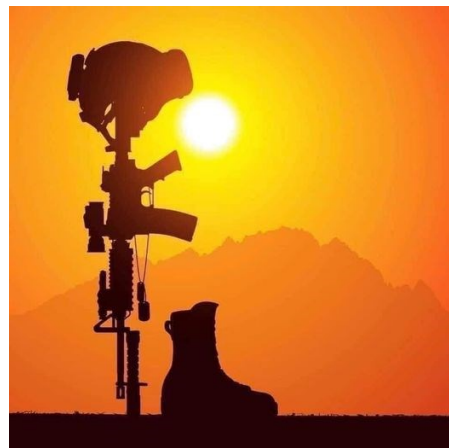

The Children's Organ Transplant Association (COTA) is a 501(c)(3) nonprofit organization based in Bloomington, Indiana, that helps children and young adults who need a life-saving organ, bone marrow, cord blood, tissue or stem cell transplant by providing fundraising assistance and family support.

COTA was founded in Bloomington, Indiana, in 1986 and has assisted over 2,200 families with over \$75 million (U.S.) raised since that time. Approximately 200 families per year receive assistance annually through COTA. COTA is the only organization of its type that charges no fee for its services and which insures that 100% of all funds donated to transplant-related expenses are used exclusively for that purpose.

Any individual under the age of 22, as well as those patients who are older but suffer from a single-gene disorder are eligible to receive help from COTA. Once engaged, a fundraising team is organized comprising a Community Coordinator, a Webmaster and a Public Relations Coordinator who then recruit other volunteers. COTA provides on-site training as well as unlimited marketing assistance to the fundraising team. Funds raised are donations to COTA, but donated "in honor of" particular patients and funds raised are held in trust for patients until such time as they are needed for transplant-related expenses. D-Day 6th of June 1944



THE LONGEST DAY

Upon the 6th of June
Remember them with pride
Men from many nations
Fighting together side by side

Raymond, stationed in Arizona, is married to the former Mary Muning, of California, and has a nine-month-old son. He is looking forward to coming back to his hometown after the war. NEW JERSEY — The remains of a New Jersey soldier who died while fighting in World War II have been identified nearly 80 years after his death.

The Defense POW/MIA Accounting Agency announced last month that U.S. Army Pvt. Roman Cherubini, 22, of Bridgeton, was accounted for on Dec. 16, 2024.

Cherubini served with the 475th Infantry Regiment in the China-India-Burma Theater, according to the DPAA.

In May 1944, Cherubini was assigned to a battalion also known as “Merrill’s Marauders.” After arriving at the captured airfield in Myitkyina, Burma, Cherubini’s battalion advanced south from the village of Mankrin on June 16 against heavily fortified Japanese positions north of Myitkyina.

Although the exact circumstances of his death were not recorded, the U.S. War Department declared Cherubini killed in action on June 16, 1944.

The remains of servicemen killed during the battle were buried in at least eight different temporary cemeteries and numerous isolated burial locations, according to the DPAA. Eventually, all known burials were concentrated into the U.S. Military Cemetery at Myitkyina, including remains that could not be identified.

In January and February 1946, the remains in Myitkyina were disinterred and transferred to the U.S. Military Cemetery at Kalaikunda, India. The remains were exhumed from the cemetery in India in 1947 and sent to a lab on Oahu for further analysis.

Despite the lab’s effort, Cherubini’s remains were not identified and he was buried as a World War II Unknown in the National Memorial Cemetery of the Pacific in Honolulu.

In 2022, the DPAA disinterred Cherubini’s remains and transferred them to an agency laboratory.

To identify Cherubini’s remains, scientists from the DPAA and the Armed Forces Medical Examiner System used dental, anthropological and mitochondrial DNA analysis, as well as circumstantial evidence.
