#### **MEMBERSHIP**

For the second straight month, we missed our target date. January we missed by 3%; February we missed by 5%. What is going on? While some squadrons are doing great, there are many doing SQUAT!

It's very embarrassing to our Detachment and to our Department that there are 33 squadrons that have less than ten members sent in and must be suspended. That means those squadrons and everyone in them are not in good standing. If squadrons don't get memberships in, they are not eligible to vote in any elections--squadron, county, or Detachment. They are also not eligible to run for any office.

So, please, get your chairman or adjutant to send in the per capita and membership cards. This is our life blood, our membership. Holding on to membership and per capita is doing harm not good for our Detachment and for National. Again, send them in to Trenton.

We are presently 379 members short of 75%, our last target date goal. Let's try a little harder to meet our 80% target by March 20. We must show the Legion that we are worthy to belong to the American Legion Family by doing better than last year in our membership drive. It's crunch time. Let's get it done.

## **GET THE WORD OUT**

New Jersey has as of February 28, 6490 members. While we should be recruiting new members, let's not forget our old ones. We must keep squadrons well informed and up and running. Currently there are 81 squadrons without officer forms on record--over 50% of active squadrons, 33 suspended, and 76 posts holding charters for suspended squadrons. Let's work on these sources for membership. pm

#### INSPIRED BY THE UNNAMED HEROES

A. L. Cmdr. Morin, S.A.L. Cmdr. Ruttkofsky, and Aux. Chaplain Koveleski at Washington Conference; Tom Marsden, Chuck Robbins, and Shirley Fabian Reflect; New Jersey Places Its Wreath in Arlington

I was honored to be part of the New Jersey Legion Family at the recent Washington Conference. I attended POW/MIA meetings and the fact-finding forum on illegal immigration. I met with national representatives--present, past, and future. I stood side by side with Legionnaires, Auxiliary, and Sons. I saw the national monuments like the Washington Memorial, the Lincoln Memorial, the Korean Monument, the Vietnam Wall, and even took a tour of the White House.

Yet still what impressed me most--after so many years and so many more visits--was Arlington National Cemetery and its Tomb of the Unknown Soldier.

As Commander Robbins and President Fabian were escorted by the honor guard to the vault, I thought of my own son Luc now serving in the Navy. Soldiers everyday are liable to be called on any day, anywhere to make the supreme act of sacrifice--sailors with their ships; pilots with their planes; land forces with sniper bullets; even soldiers still on American soil. That is how it must be when a country is at war.

I believe every casualty deserves to be remembered. Each man or woman gave all for God and country. The Tomb of the Unknown Soldier stands for the bravery, valor, and honor that our military has shown and continues to show throughout our country's history.

There is little consolation to anyone who loses a loved one, still I am sure that the knowledge that the country remembers and cares helps. Fellow Americans, be proud of those who returned and even prouder of those who didn't.

#### WHAT DO YOU THINK \* AN EDITORIAL

How can the United States accept more legal immigrants when at present there are over ten million aliens in this country illegally? The American Legion feels that national security, the national economy, and the welfare of our descendants must be considered.

U. S. Senator Sessions (AL), Alfonso Aguilar, U. S. Citizenship and Immigration Services, Mark Krikorian, Center for Immigration Studies, Kris Kobach, Kansas City School of Law, Roy Beck, NumbersUSA, and Dr. John Forte, Hudson Institute all participated in a fact-finding forum on this topic.

The general consensus was that illegal immigration takes away from the open door to legal immigration. It has adverse economic effects as unskilled labor brings wages down. The U. S. A. must be able to defend its borders and needs comprehensive reform.

These are the American Legion's key positions on illegal immigration:

- (1) The Legion is not against guest worker programs; it is opposed to amnesty.
- (2) It supports enforcement of employer sanctions and civil penalties for those who hire illegals.
- (3) It calls on Congress to secure borders as needed.
- (4) It calls upon all law enforcement agencies to share database information and have federal, state, and local law enforcement arrest and detain those violating immigration laws.
- (5) It is against foreign-isssued forms of dentification that are not creditable, authentic, and accurate and supports tracking foreign students and monitoring their attendance.
- (6) It opposes giving illegal immigrants Social security benefits, unemployment compensation, other taxpayer supported public assistance, and in-state, federal and other government educational assistance grants.
