The philosophy of "Josh" dog project is to help comfort children going through a surgery.

The "Josh" dog program, aligns with one of the four Legion pillars to support children and youth. Sons of The American Legion have four pillars, and they are Veterans Affairs and Rehabilitation, National Security, Americanism, and children and youth.

When the detachment of New jersey learned of a 4 year old child fighting Leukemia in

North Carolina, Commander Amel Balega along with Chairman Jackson Coles had a Josh Dog expressed to this young boys bed side , delivered by National Commander Past Steve Laws (2002-2003).

American Legion Auxillary President Charlene Mc Conville received a Josh Dog for her grandson Marcus who was admitted into the hospital suddenly in Tennessee, where he was diagnosed with chronic asthma.

Josh is reaching sick children and assuring them "I'll be ok"

Each package costs \$40.00 and includes a hypo allergenic plush golden retriever, a 32page hard cover book, and dog house packaging that provides an easy to tote, temporary home for Josh. Contact Jackson

Detachment Visits Chaplains Hill

Arlington Cemetery: Members of the Detachment of New Jersey Sons of the American Legion gathered on chaplains hill to pay homage to the courage chaplains who enbodied the true meaning of For God and Country. A wreath honoring these mens sacrifice for our country was placed at the monument for the Jewish chaplains.

A sleek, granite memorial inscribed with the names of 14 Jewish Chaplains who died while in military service now stands beside memorials to their Roman Catholic and Protestant brethren on Chaplains Hill at Arlington National Cemetery.

But this was not always the case.

Ken Kraetzer, a Sons of the American Legion member from New York who first brought the absence of a Jewish chaplains memorial in Arlington to light several years ago. Kraetzer and Robinson were the principal figures in launching the campaign to compose a Jewish memorial alongside existing ones dedicated to fallen Roman Catholic, Protestant and World War I chaplains. And a resolution endorsing the Jewish Chaplains Memorial was adopted during the Legion's 93rd national convention in Minneapolis.

"I called the Jewish War Veterans after discovering that (Goode was not recognized at the cemetery)," Kraetzer said, "and they put me in touch with Jewish chaplain Rear Admiral. Harold Robinson. I like to say we have been on a nearly three-year mission ever since." The campaign to create the new stone and plaque ultimately required an act of Congress.

The formal dedication for the Jewish Chaplains Memorial will be Oct. 24, 2011 at Arlington's Memorial Ampitheater.

The first chaplain's name on the memorial is Rabbi Alexander D. Goode, one of four chaplains who died Feb. 3, 1943, off the coast of Greenland aboard the transport ship Dorchester after it was torpedoed by a German submarine.

Over the years, memorials were placed at Arlington National Cemetery for

Washington, Poling and Fox, but not for Goode. There was no monument to recognize Jewish chaplains. Memorials were dedicated to all the chaplains who died in World War I, another to honor Protestant chaplains who died in World War II and another that memorialized the Roman Catholic chaplains who had died in World War II, Korea and Vietnam.

The American Legion formally designated April as Children Welfare month in 1938. That designation was later changed to Children & Youth month in recognition of the Fourth Pillar on which the American Legion was founded. Our Most Precious Natural resource."

The Flag Amendment

Legion family members are encouraged to contact their U.S. representatives and urge them to sign on as cosponsors of the recently introduced flag amendment. Click here to contact your elected officials

The American Legion is urging all concerned citizens, veterans and their families to "rally once again 'round the flag" and contact your senators and representatives, encouraging them to become co-sponsors of this legislation.

In 1989, the U.S. Supreme Court's landmark, but erroneous, decision in Texas v. Johnson (5-4 vote) overturned 200 years of American tradition and laws by declaring that the people no longer had a right to protect the American flag. The court ruled flag burning was protected "speech" as defined by the First Amendment, and invalidated laws in 48 states and the District of Columbia.

Only a constitutional amendment can protect the flag. Rather than fearing such a constitutional amendment, members of Congress concerned about supporting the amendment should embrace it. It is a profound demonstration of the feeling of the American people, and is the people's timehonored way of correcting erroneous constitutional interpretations of the Supreme Court. The proposed flag-protection amendment is no infringement on the Bill of Rights; it is instead, a wonderful exercise in the popular sovereignty the Bill of Rights was designed to protect.

Contact your legislators and urge them to co-sponsor the amendment.

American Legion Boys State and American Legion Auxiliary Girls State are the premier programs for teaching how government works while developing leadership skills & an appreciation for your rights as a citizen. As a participant in the program boys and girls, will run for office, learn public speaking, create and enforce laws and actively participate in all phases of creating and running a working government in this exciting and fun summer program.

The detachment will be sending two boys to boy state this year, one from Cumberland, and one from Essex county If your squadron is able to sponsor a boy to Boy State or young lady to Girls State, please do. It's a great program that they will never forget. The cost to send one boy is \$250.00; which is not a great amount considering all it includes. If your Post, Squadron or Unit is not able to sponsor a child, you may solicit finds from an outside group (a local business, the Elks, etc...).

The Boys State committee is trying to push the number of boys at boy's state this year to 1000 boys. Last year's count was 960 boys. If we pull together we can do it.
