The Detachment of New Jersey hosted its convention at the Wildwood Convention Hall on June 9. Dignitaries in attendance included National SAL Commander Sparwasser and Leading National SAL Commander Candidate Ruttkofsky. Tom Engleterria, Regional Coordinator of the National POW/MIA League of Families, was the keynote speaker.

New Jersey is honored to have Mike Arner (CWF), Carl Albern (Community Relations), Ken Esposito (Paid Up For Life), and Tom Marsden (National Security) at national. We can look with pride to accomplishments like donating \$9,906 to CWF, \$1,670 to Special Olympics, \$1,335 to the National Emergency Fund, \$875 to the Children's Miracle Network, and 25 Spinoza Bears to children of deployed military.

Cmdr. Arner promises to be busy bringing the meetings to the membership. On the months that meetings are not held in Trenton, meetings will be held around the state to build membership. The first is scheduled for July 8 at Post 175 Rockden.
