Fight for Pledge at Supreme Court

With the Supreme Court announcement that it will decide in 2004 whether it is constitutional for public-school teachers to lead students in the Pledge of Allegiance because of the words "under God," the nation's largest veterans organization pledged its commitment to fight this at the highest judicial level for the right of public-school teachers and students to voluntarily observe the time-honored tradition.

"The heart of this case is about allowing the Constitution to appropriately reflect the intent of our republic's founders and the values of the American people," American Legion National Commander John Brieden said. "We believe our nation will be stronger when the courts let our Constitution protect the rights of all the people rather than merely the wrongs of a few people."

"The American Legion filed a friend-of-the- court brief in support of the constitutionality of the Pledge of Allegiance at Federal Court in San Francisco. The American Legion is committed to take this fight all the way to the highest court in the land. Teachers leading students in the Pledge of Allegiance is as constitutional as "In God We Trust" stamped on our nation's currency and references to "God" in the oaths taken in our courts.

"But this case is bigger than the Pledge. What is really at stake here is the moral direction of the nation. The right of the people to declare their patriotism by voluntarily reciting the Pledge is but one battle. The right of the Boy Scouts of America to select its leaders consistent with its founding principles is another battle. The right of the people to protect the U. S. flag from acts of physical desecration is a battle that The American Legion has been fighting since the Supreme Court in 1989 invalidated flag-protection in 48 states; a constitutional amendment approved by the House and soon to come to vote in the Senate is the remedy."

The 9th U. S. Circuit Court of Appeals in San Francisco ruled 2-1 in June 2002 that reciting the Pledge in public schools is unconstitutional. The court reaffirmed its decision in February, amending the ruling to say that "teacher-led" recitation of the Pledge is unconstitutional. The rulings came after Michael Newdow, an atheist and father of an elementary school girl, filed the case against the United States, Congress, California, and two school districts.

Newdon's daughter lives with her mother, who has sole custody of the young girl. The daughter attends public school in Elk Grove, Calif., near Sacramento and according to reports regularly attends church. Newdon's complaint alleged that his daughter is injured when she is compelled to watch and listen as her state-employed teacher in her state-run school leads her classmates in a ritual proclaiming that there is a God and ours is one nation "under God."

In 1954, President Dwight D. Eisenhower signed legislation inserting "under God" after the words "one nation." The American Legion supported the addition. "We have full faith the court will uphold the right of the people as one nation under God," Brieden said.

Commander's Project

"Quality of life for our N. J. Veterans," Cmdr. Kent Hehl announced at his October meeting. After numerous visits and gatherings of information at Menlo Park, Paramus, Vineland Memorial Home, and Veterans Haven facilities, Cmdr. Hehl has noted the areas needing immediate attention and is currently setting goals.

The first phase of his project will be for Veterans Haven, a transitional housing program for homeless New Jersey veterans. The program assists our veterans in their transition from the streets and causes of their homelessness to the community living as productive and contributing citizens. Here he found that the home is in need of 54 8,000 BTU room air conditioners.

This will be a large undertaking by the SAL Detachment but Cmdr. Hehl is very enthusiastic about this project and knows that the Legion Family of New Jersey cares about their veterans. He is hopeful that all will support this with a large contribution.

As an incentive, Cmdr. Hehl. will honor any squadron, post, or unit who will sponsor an air conditioner installation by donating \$200, which will include an engraved plate to be placed on the air conditioner denoting the sponsor's name. For those who will make a personal donation of at least \$10 to this project Cmdr. Hehl will give a Detachment Commander's Project Pin.

Phase Two of the project will be for all of the state facilities to supply CD players for their activity rooms and individual CD players with earphones for the patients in the Alzheimer's units. These patients respond to the senses, ex. sight, sound, aroma, and touch therapy.

Phase Three of the project will be to assist Department Commander Behr and Department President Newlin with their project concerning the Alzheimer's units in our state facilities.

Donations are to be made out to SAL Detachment of New Jersey, earmarked (memo line) Detachment Commander's Project. To reach Cmdr. Hehl's goal, donations of \$15,000 will be needed.
