#### **SONS SUPPORT POW-MIA'S**

At the 15th Annual American Legion Tree Lighting Ceremony at Shore Boro Post #351 Seaside Heights, Detachment Commander Howarth congratulated Chairman Robbins for all his efforts and thanked the National League of POW-MIA Families for all it does. Before a packed house, he went on to say:

"The most precious American right is freedom freedom to go and do nearly anything we wish, freedom to worship as we please, freedom of speech, freedom of the press, and, as we know, the list goes on--freedoms that some of us take for granted.

"There are those who have had that freedom denied for far too long. With each passing year, it is more difficult for us to remember the more than 88,000 POW-MIA's still missing from World War II, Korea, the Cold War, the Gulf War, and now Afghanistan and Iraq.

"Our hearts, our thoughts, and our prayers remain with our POW-MIA's and their families. As the solemn pledge beneath the POW-MIA emblem swears: You Are Not Forgotten. We will wait. We will remember. We will not rest until there is a full accounting of our missing heroes.

"We must remain vocal, devoted, and critical in order to keep the POW-MIA issue on America's mind. Although may take a lifetime of dedication to rectify to past and secure the future for America's prisoners of war and missing in action, we must never forget.

"The Sons of The American Legion remain vocal every year through the Watchfire held in September. We cannot and will not forget until we have the fullest POW-MIA accounting.."



#### CATHEDRAL OF THE AIR

I recently saw pictures of a stained glass window in a shrine in Orlando. It showed four sailors going down with their ship. Theirs was a real "For God and Country" story of heroism.

On February 3, 1943, Father Washington, Rabbi Goode, Reverend Fox, and Reverend Poling were among the 902 men onboard the sinking USAT Dorchester in the North Atlantic. Chaos and panic was everywhere. They, as chaplains, calmed the frightened, tended the wounded, guided the disoriented. They prayed for the dying and encouraged the living.

Each man did not merely preach courage; he lived it. Now these men of God were about to be tested when no more life preservers were left for the men still lined up. How would each respond given the choice of ministering to others vs saving himself?

Simultaneously, each of the four chaplains removed his own life preserver and gave to the next man in line. The spiritual act transcended religious differences. They were united in their universal love of mankind.

Washington, Goode, Fox, and Poling went down with the ship--kneeling, arms linked, huddled together, heads bowed, praying. How gallant, noble, and heroic they were!

We know that it doesn't matter if our brother is Christian, Catholic, or Jew. While the War on Terrorism which began in attacks on our homeland on 9-11, continues to go on in foreign lands, we must all live our lives with courage and determination, in faith.
