BE THE ONE Campaign

The American Legion, Dept. of NJ, is diving to greater depths in support of the ***Be the One*** campaign, initiated by 2021-2022 National Commander Paul E. Dillard. **NJ Dept. Commander Steven Fisher** kicked off the first quarter of his leadership year with an awareness campaign and a plea to NJ Legionnaires to lead by example.

The ***Be the One*** campaign is a direct message to American Legion members, Veterans and the public to reach out to Veterans to see how they are doing. "We must make an impact in our communities to minimize the number of suicides by Veterans. One suicide is too many," he said.

Fisher is being proactive by pledging to directly contact NJ Legionnaires and other Veterans living in the state. He is making phone calls, sending emails, texting messages and creating public service announcements to directly contact all Veterans who reside in NJ, and he is asking fellow NJ Legionnaires and Veterans to do the same.

The NJ American Legion ***Be the One*** campaign would like all Members who have served and who are currently serving in the US Armed Services to reach out to their Comrades. One phone call, text message, email or in-person communication can make all of the difference in a Veteran's life. It could mean life or death.

The ***Be the One*** campaign asks you to ***Be the One*** to: - Ask Veterans in your life how they are doing. - Listen when a Veteran needs to talk. - Reach out when a Veteran is struggling.

PACT ACT & GULF WAR, POST-9/11 ERA VETERANS

The PACT Act, signed into law August 10, 2022, expands health care eligibility to several groups of Veterans who may not have been eligible before.

Veterans who participated in a toxic exposure risk activity (as defined by law) while serving on active duty, active duty for training, or inactive duty training.

Veterans assigned to a duty station (including airspace above) certain locations during specific periods of time on or after:

- August 2, 1990, in Bahrain, Iraq, Kuwait, Oman, Qatar, Saudi Arabia, Somalia, or United Arab Emirates
- September 11, 2001, in Afghanistan, Djibouti, Egypt, Jordan, Lebanon, Syria, Uzbekistan, or Yemen, or any other country determined relevant by VA.

Veterans who deployed in support of:

- Operation Enduring Freedom
- Operation Freedom's Sentinel
- Operation Inherent Resolve
- Operation Iraqi Freedom
- Operation New Dawn
- Resolute Support Mission

SPECIAL ENROLLMENT PERIOD: Veterans who served on active duty in a theater of combat operations during a period of war after the Persian Gulf War or in combat against a hostile force during a period of hostilities after November 11, 1998, and who were discharged or released between September 11, 2001, and October 1, 2013, may enroll in VA health care between October 1, 2022 and October 1, 2023.

Family members or dependents of a deceased Veteran may qualify for various VA benefits due to the additional disabilities defined in the PACT Act if they meet eligibility requirements. More information for survivors is available online at VA.gov/PACT.

2022 PACT ACT: UNDERSTANDING HEALTH CARE ELIGIBILITY AND BENEFITS

PACT ACT OVERVIEW

What is the PACT Act? Why is it important?
The PACT Act is a new law that expands VA health care and benefits for Veterans exposed to burn pits and other toxic substances. This law helps us provide generations of Veterans—and their survivors—with the care and benefits they've earned and deserve.

What does the acronym, PACT, stand for?
Sergeant First Class Heath Robinson Honoring Our Promise to Address Comprehensive Toxics (PACT) Act of 2022.

When does the law go into effect?
While some provisions take effect at different times, VA considers the presumptive conditions established in the PACT Act to be applicable on the date the PACT Act was signed into law (August 10, 2022). All Veterans and survivors who believe they may be entitled to benefits are encouraged to apply today.

What are the PACT Act key components?

- The Act expands and extends eligibility for VA health care for Veterans with toxic exposures and Veterans of the Vietnam era, Gulf War era, and Post-9/11 era.
- VA will improve the decision-making process for determining what medical conditions will be considered for presumptive status.
- Every enrolled Veteran will receive an initial toxic exposure screening and a follow-up screening at least every five years. Veterans who are not enrolled, but who are eligible to enroll, will have an opportunity to enroll and receive the screening.
- VA health care staff and claims processors will receive toxic exposure-related education and training.
- The Act requires research studies on mortality of Veterans who served in Southwest Asia during the Gulf War, Post-9/11 Veteran health trends, and Veteran cancer rates.
- The Act will help VA build a stronger, more skilled workforce to meet the growing demand for benefits and services.
- The Act authorizes 31 new facilities across the country, providing greater access to VA health care.

What is Toxic Exposure?
As a general matter, there are several types of possible exposures or hazards Veterans may have experienced during their military service, including:

- AIR POLLUTANTS:** Burn pits, oil well fires, sulfur fire, sand, dust, and particulates
- CHEMICALS:** Agent Orange or other herbicides, burn pits, Camp Lejeune water supplies, pesticides, depleted uranium, chromium, or industrial solvents
- RADIATION:** Nuclear weapons testing, x-rays, or depleted uranium
- WARFARE AGENTS:** Chemical warfare agents, nerve agents, mustard gas, herbicide tests, and storage
- OCCUPATIONAL HAZARDS:** Asbestos, lead, fuels, industrial solvents, radiation, vibration, noise, special paint on military vehicles, and some coolants or insulating fluids

Detachment News:

At the Detachment meeting held on 1-October at Post 87 in Woodbridge, there were no applications from anyone to fill the vacant fifth Vice Commander position. In the meantime, the four current Vice Commanders will each take a County normally assigned to that open position. The Counties in question are Hunterdon, Mercer, Sussex, and Warren.

The Vice Commanders and the counties they now cover: Keith Barnes (Sq 58) Middlesex, Mercer, Sussex, and Warren; Richard Hodum (Sq 166) Burlington, Cumberland, Gloucester, and Ocean; William Murphy (Sq 348) Atlantic, Camden, Cape May, and Salem; Stephen Sangemino (Sq 105) Bergen, Essex, Hudson, Monmouth, and Passaic.

The fifth Office of Vice Commander remains open. Any Son in good standing wishing to be considered for the Office should contact Detachment Adjutant Carl Albern Jr. (346) at albern@njsal.org for details.

As of 30-September-2022, the Detachment Membership stands at 9189 Members. We are so close to our goal of 10,000. Squadrons should step up their recruitment efforts, and of course follow up on renewals. And don't forget buddy checks. Give a call, an email, a text, or stop by and see how they're doing. You just might BE THE ONE.

There's a possibility of a BE THE ONE Committee and classes. It's now reported to be 23 A DAY we're losing due to preventable suicide. Need help? Easy number to remember: 9-8-8.

A new SAL emblem is in the works, to go along with the Legion's new logo. Anyone using the copyrighted emblems is required to contact www.legion.org/emblem.request and fill out the form before using any of the Legion Family emblems.

The “Flying Flags for Heroes” program instituted by Past National Commander Michael Fox, planned to place a million Flags on the graves of Veterans, far exceeded that goal. NEC Bob Phillips Jr. (262) reported 1.835 million Flags were placed nationwide. Let’s keep this going for this year.

An American Legion Family Day is in the works for April 2023.

Also in April, 28-29-30 to be specific, Legion and SAL College will be held at Sea Girt. Details and forms will be sent out in January.

NEC Bob Phillips Jr. (262) presented a \$100 check to Commander Mark Natale toward his Commander’s Project. The check was from the Auxiliary Unit 262 from Audubon.

PDC Bob Bascou (371) stated that an American Legion Baseball Committee should be established ASAP and this worthwhile program be restarted.

DEC Rusty Myers (105) spoke of his own son’s involvement in the Ten Ideals Program and we should establish more of these on a local Squadron basis, jointly with the Junior Auxiliary.



Lone Civil War Veteran's Grave at the side of the Garden State Parkway

If you're heading southbound on the Garden State Parkway, at around mile marker 6.1, look for the grave of Noah Cherry, an African American Civil War veteran who was born in North Carolina in 1831 and died in New Jersey in 1907.

A reader named Terry told us that Mr. Cherry might be the same person as Earnest A. Cherry, who was a farmer and founding landowner in Whitesboro, a planned "Negrotown" that was founded in 1900. Whitesboro itself was named after one of its founders, George White, a Reconstruction Congressman from North Carolina who sold shares in the planned community to other African Americans, mostly from North Carolina and Virginia.

But Noah might just be Noah, as a December 16, 1973 article in a local newspaper claimed. According to the article, Noah was a former slave, and a private in Company H, 36th Regiment of the U.S. Colored Volunteers during the Civil War. The reporter tracked down a woman who was related to Mrs. Wiley Jane Williams, "a distant relative of Cherry's who knew him during his last years." Mrs. Williams had written a recollection of Cherry that tells so much about the man buried beside the Parkway.

He was one of the men, she wrote, "Who marched with General Sherman to the sea." He first arrived in Whitesboro from North Carolina in 1903, built a small frame house on Main Street, and sent for his family. He helped Mrs. Williams' father with hog butchering and he loved to sing in a "clear baritone voice," especially a hymn by Issac Watts that he'd sing to the tune of "Auld Lang Syne."

He once almost died from mistakenly inhaling turpentine, and for a few hours actually appeared dead, but he revived, much to the happiness of everyone. And there's a supernatural story attached to his real death in 1907, as Mrs. Williams wrote:

One night Uncle Noah heard a loud sound at his door...(but) whatever it was...had left and was going through the darkness across the field in a great whirlwind and was shouting so loudly that it was deafening, "Lazarus Laws, Lazarus Laws, Lazarus Laws, Lazarus Laws!" It was a mournful, wailing, unearthly sound. Noah Cherry didn't know what to make of it, but that night, Mr. Lazarus Laws died. Soon after, both Cherry and the man who lived in the house the shouting thing was traveling toward died.

Noah Cherry was buried in the "old graveyard" and his body and that of a few others stayed there until 1955, when construction on the Parkway intruded and the graves were moved. The newspaper story mentions the presence of a second gravestone belonging to General S. Askew and one for another Askew family member, but those were gone in 1973 and definitely not there today, though the grave of Noah Cherry still is.

Lyndhurst American Legion Post 138 maintains the grave and places flags there each year.
