His first position for the Detachment of New Jersey was Assistant Sgt at Arms, then 3 years as Vice Commander. Henry earned a Bachelor's Degree in Marine Sciences from Stockton State College, now Stockton University, and an Associate's Degree in Fire Science Technology from Camden County College. He is also a certified wild land fire instructor.

Henry is a retired Assistant Division Fire Warden from the New Jersey Forest Fire Service. In this position he was responsible for training, operations, and fire prevention for the counties of Camden, Atlantic, Gloucester, Cumberland, Salem, and Cape May. He also supervised the 12 Fire Wardens assigned to these counties. He continues to fight wildfires in NJ and usually assists in coordinating the incident. He works on a National Type 1 Incident Management Team responding to major wild fires and all hazard incidents throughout the United States.

There he works in logistics and assists in managing the incident. He was deployed for hurricane relief from hurricanes Sandy and Irene, and with the New Jersey State Police in Puerto Rico for hurricane Maria.

At the community level he is a Life Member in the Waterford Twp Fire Department. Serving 20 years total achieving the rank of Assistant Chief, and one year as Township Fire Chief. He is also currently the President of the Atco Cemetery Association.

Henry has been married to Jean for 45 years. He has 2 children, Henry P Hasselhan, and Stephanie Bowker and 5 grandchildren.
